TO ALL EMPLOYEES OCCUPYING POSITIONS IN THE CLASSIFIED SERVICES OF JEFFERSON COUNTY, INCLUDING THE PERSONNEL BOARD OF JEFFERSON COUNTY, JEFFERSON COUNTY BOARD OF HEALTH, GENERAL RETIREMENT SYSTEM OF JEFFERSON COUNTY, AND JEFFERSON COUNTY EMERGENCY MANAGEMENT AGENCY

A law (No. 248, H 580) enacted by the Legislature of Alabama Regular Session 1945, approved by the Governor on July 6, 1945, and amended by Act No. 97, 1956; Act No. 476, 1957; Act No. 591, 1967; and Act No. 684 of the 1977 Legislature, provides that the occupant of a position in the Classified Service of Jefferson County, including employees of the Jefferson County Board of Health and Jefferson County Emergency Management Agency, shall be elected each year to serve as a member of the Citizens Supervisory Commission. Said member is to be elected by the Classified Employees of Jefferson County, Jefferson County Board of Health, and the Jefferson County Emergency Management Agency. The one-year term will commence on November 1, 2024 and end on October 31, 2025. There are two meetings a year, the third Tuesday in November and May, at noon, and special meetings as scheduled.
